**DECLARATION OF HÅKAN LANS
IN SUPPORT OF THE MOTION FOR PROMPT DECISION ON
THE PENDING MOTION FOR RECONSIDERATION
AND REQUEST FOR A HEARING**

Håkans Lans declares:

1. I am the plaintiff in the above-captioned cases Nos. 97-2523 (JGP) and 97-2526, and I am the sole shareholder of the plaintiff in the above-captioned case No. 99-3153 (JGP). I make this Declaration on personal knowledge in support of the Motion for Prompt Decision on the Pending



Motion for Reconsideration of the Court's September 6, 2001 Order Concerning Attorney's Fees and Request for a Hearing. This Declaration supplements my Declaration of January 16, 2002, filed in support of the Motion for Reconsideration.

2. My family's life changed dramatically when I got the Court's decision in 1999. For the first time in my life my credibility was questioned. It was so unreal and horrifying that my request to testify has been rejected and that I had not been given a chance to give my views. In the important question if I or Adduci, Mastriani & Schaumberg, my former lawyers, had failed I was not even represented in the court because Mr. Mastriani represented AMS's position and not mine.

3. After some time I also realized that it was the end of my career as a scientist. I also realized that my family most likely would be ruined. I realized that I must terminate all my research project and all my financial commitments. I started to sell my companies' assets but it was difficult to get money for very specialized equipments.

4. In 1999 I was an internationally high ranked scientist but after that I stopped work as a scientist and used all time to defend myself. Whatever happens I can never recover and my career is over. My wife and I are both continuing to suffer the effects of the Court's decision.

5. I continue to have faith that the Motion for Reconsideration will vindicate me and prove the true facts and restore my reputation. In the meantime, however, the Court's delay in ruling continues to have devastating effects on a personal and professional level.

6. On Swedish television news, on October 3, 2000, Swedish Minister of Industries Leif Pagrotsky has said about me and the situation that I am currently in: "No human being should be forced to live under such conditions – it is not acceptable, this type of threat against a person who has made the world such big favors with his inventions."
